• Access Monitoring - Dave Rysdam and Tom Mahoney (Incoming AIS Chair), along with Jim Schultz (Outgoing AIS Chair) have devised a go forward Access Monitoring plan. This plan - endorsed by both the KLHA and KLID boards - promotes boater awareness and compliance with Aquatic Invasive Species prevention laws, at a reasonable and sustainable cost.
