Secretary's report:

The minutes of the May 29, 2010, Kimble Lake Improvement District Annual Meeting were read and approved after a correction of the assessment amount which read as \$130.00 and should be \$110.00. The motion was made by Harvey Hollenback with a second by Ed Sisola.

Crow Wing County Financial Report:

The KLID financial report highlights included a balance of \$10,228.76 on 1/1/2010. Assessments collected by the county for the KLID were \$13,765.62. Expenditures were \$7,030.28. The cash balance as of 12/31/2010 was \$16,964.10, which will be available for services in 2011. A general discussion of money spent for lake inspection and treatment services followed this report. A motion to dismiss the professional services of Ron Duy for inspection and treatment and to substitute trained lake residents to provide these services was made by Marsh Pechauer and seconded by Ron Pettit. Several homeowners spoke in support of Mr. Duy's services. The motion was defeated.
